If YA is applied by the RO through the RO Determined Yield or through RO UG then the AIP must send the YA option code on the acreage record through PASS. If YA was elected on a non-contiguous rated crop, then the surcharge flag on the acreage record must also be set to establish the .05 multiplicative rate. The yield record will not include the YA option codes. See AD for crops with the surcharge.
