Crop Insurance Deadline Nears in West Virginia

Livestock Risk Protection

RALEIGH, N.C., May 31, 2019 – The USDA's Risk Management Agency (RMA) reminds West Virginia livestock producers of the availability of the Livestock Risk Protection (LRP) insurance for Fed Cattle, Feeder Cattle, Lamb, and Swine. Livestock producers interested in LRP are encouraged to apply for the endorsement.
