The Policy Producer Address, "P10A" record must be submitted between 7/1/2014 and 10/11/2019.

The Policy Producer Address, "P10A" record will not be accepted when processing has been suspended for this record type per RMA directive.

The parent Policy Producer, "P10" record must exist for the Policy Producer Address, "P10A" record to be accepted.

The parent Policy Producer, "P10" record must be free of errors for the Policy Producer Address, "P10A" record to be accepted.

A Policy Producer "P10" record, must be accepted before a Policy Producer Address, "P10A" record, will be accepted.
