2020 ADM Area Coverage Level and ADM Price updated to issue final index payment factors for Annual Forage, Apiculture, and PRF intervals 632 and 638 with an ending month of September, reference PM-20-079, 4/30 and 8/31 filings. 2021 RY ADM and Special Provisions are now issued for the 11/30 and 12/31 filings except for Hybrid Popcorn Seed, Hemp, Sweet Potatoes, Sesame, Flue Cured Tobacco, Hybrid Sweet Corn Seed, and Hybrid Seed Rice.
