Crop Insurance Deadline Nears in Mississippi for Spring Planted Crops and Whole-Farm Revenue Protection

JACKSON, Miss., Jan. 31, 2022 — The USDA’s Risk Management Agency (RMA) reminds Mississippi corn, cotton, grain sorghum, peanuts, rice and soybean producers that the final date to apply for crop insurance coverage for the 2022 crop year is February 28. Growers who are interested in the Whole-Farm Revenue Protection (WFRP) policy and are calendar year or early fiscal year filers, have until February 28 to apply for crop insurance. Current policyholders who wish to make changes to their existing coverage also have until the February 28 sales closing date to do so.

Federal crop insurance is critical to the farm safety net. It helps producers and owners manage revenue risks and strengthens the rural economy. Coverage is available for corn, cotton, grain sorghum, peanuts, rice, soybeans and WFRP in select Mississippi counties. Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2022 crop year.

RMA is authorizing additional flexibilities due to coronavirus while continuing to support producers, working through Approved Insurance Providers (AIPs) to deliver services, including processing policies, claims, and agreements. RMA staff are working with AIPs and other customers by phone, mail and electronically to continue

supporting crop insurance coverage for producers. Farmers with crop insurance questions or needs should continue to contact their insurance agents about conducting business remotely (by telephone or email). More information can be found at farmers.gov/coronavirus.
