## Crop Insurance Deadline Nears in Alabama for Nursery Value Select Growers

VALDOSTA, Ga., April 5, 2022 — The USDA's Risk Management Agency (RMA) reminds Alabama Nursery Value Select growers that the final date to apply for crop insurance coverage for the 2022 crop year is May 1. Current policyholders who wish to make changes to their existing coverage also have until the May 1 sales closing date to do so. Growers applying for the first time may purchase coverage at any time.

Federal crop insurance is critical to the farm safety net. It helps producers and owners manage revenue risks and strengthens the rural economy. Coverage is available for Nursery Value Select in Baldwin and Mobile counties.

Coverage begins 30 days after receipt of a signed application and approval of required documents. For Nursery Value Select coverage, a Nursery Value Report, Monthly Unit Value Plan, and two copies of the grower's most recent catalog is required. Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2023 crop year.

RMA is authorizing additional flexibilities due to coronavirus while continuing to support producers, working through Approved Insurance Providers (AIPs) to deliver

services, including processing policies, claims and agreements. RMA staff are working with AIPs and other customers by phone, mail and electronically to continue supporting crop insurance coverage for producers.
