[**Crop Insurance Deadline Nears in North Carolina for Cabbage, Corn, Cotton, Grain Sorghum, Hemp, Peanuts, Sesame, Soybeans, Flue Cured Tobacco, and Whole-Farm Revenue**](#)

RALEIGH, N.C., Jan. 26, 2024 — The USDA’s Risk Management Agency (RMA) reminds North Carolina cabbage, corn, cotton, grain sorghum, hemp, peanut, sesame, soybean, flue cured tobacco and Whole-Farm Revenue growers that the final date to apply for crop insurance coverage for the 2024 crop year is February 28. Current policyholders who wish to make changes to their existing policies also have until February 28 to do so.

Federal crop insurance is critical to the farm safety net. It helps producers and owners manage revenue risks and strengthens the rural economy. Coverage for green peas is available in select counties. Additional information can be found on the [Actuarial Information Browser](#) page on the RMA website.

Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2024 crop year, including insurance for cabbage, corn, cotton, grain sorghum, hemp, peanut, sesame, soybean, flue cured tobacco and Whole-Farm Revenue. For the 2024 crop year, sesame insurance is available in the state via written agreement. Additional crops or counties may be eligible for coverage under a written agreement. Crop insurance coverage decisions must be made on or before the sales closing date.

RMA is authorizing additional flexibilities due to coronavirus while continuing to support producers, working through Approved Insurance Providers (AIPs) to deliver services, including processing policies, claims and agreements. RMA staff are working with AIPs and other customers by phone, mail and electronically to continue supporting crop insurance coverage for producers.
