Crop Insurance Deadline Nears in North Carolina for Spring Planted Crops

RALEIGH, N.C., Feb. 15, 2024 — The USDA's Risk Management Agency (RMA) reminds North Carolina burley tobacco, cucumber, fresh market bean, fresh market sweet corn, fresh market tomato, and processing bean growers that the final date to apply for crop insurance coverage for the 2024 crop year is March 15. Current policyholders who wish to make changes to their existing policies also have until the sales closing date to do so.

Federal crop insurance is critical to the farm safety net. It helps producers and owners manage revenue risks and strengthens the rural economy. Coverage for burley tobacco, cucumbers, fresh market beans, fresh market sweet corn, fresh market tomatoes, and processing beans is available in select counties. Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2024 crop year. Additional crops may be eligible for coverage under a written agreement. Crop insurance coverage decisions must be made on or before the sales closing date.

RMA is authorizing additional flexibilities due to coronavirus while continuing to support producers, working through Approved Insurance Providers (AIPs) to deliver services, including processing policies, claims and agreements. RMA staff are working with AIPs and other customers by phone, mail and electronically to continue supporting crop insurance coverage for producers.
