2019 RY ADM Area Coverage Level and ADM Price are updated to issue final index payment factors for Annual Forage, Apiculture, and PRF interval 633 with an ending month of October, reference PM-19-075, 4/30 and 8/31 filings. 2020 RY ADM Area Coverage Level and ADM Price are updated to issue final index payment factors for Annual Forage Growing Season 1, reference PM-19-075, 4/30 filing. 2020 RY ADM Historical Yield Trend and ADM Insurance Offer are updated to correct Historical

Yield Trend IDs for corn (ARPI/SCO/MP) in Bremer (017), Marshall (127), and Story (169) Counties, IA (19), 6/30 and 11/30 filings. 2020 RY ADM, Special Provisions, and related files are now issued for the 1/31 filing except for Pecan Trees, new programs Apple Trees and Nursery (NVS), and prices (all crops except Nursery (FG&C)) which will be released by January 31.
