Additional notes and details regarding this data release:

2015 ADM Price updated for the harvest price announcement, PM-15-051, 11/30 filing. 2016 ADM Layout expanded max length of county yield field on Base Rate (A01010) for Hybrid Seed Rice (0080) revised county yields, 11/30 filing. 2016 Margin Protection Plan commodities now have ADM record types populated/updated A00045, A01100, A01115; 6/30 and 11/30 filings. 2016 ADM Option Rate updated to add "CP" to apples (fresh: intended use code 101) and processing beans (conventional: organic practice 997), 8/31, 10/31, and 11/30 filings. 2016 SCO commodities (TX oats and wheat; MO hybrid corn seed; popcorn; and 3 counties of dry peas) in isolated counties now have proper statements populated via ADM Document Builder, 6/30 and 11/30 filings. 2016 SCO dry peas in 3 counties (16-055, 46-021, and 46-119) now have all insurance offers populated along with associated ADM data, 11/30 filing.
