2016 ADM Price updated to: 1) populate CBVs (county base values) on Apiculture, 2) populate minimum and maximum acre percent's on CA PRF haying (type 030), and 3) show the price under the projected price versus establish price on ARPI

forage production, 8/31 filing.

2016 ADM Price rows updated to null out the maximum contract price, maximum contract price factor, and the contract price code fields on Concord grapes (APH/SCO, type code 200) in Oregon and Washington state, 8/31 filing.

2015 ADM Price now populated with the price code indicator of "CP" on silage sorghum for PASS processing, 11/30 filing.
