2017 Annual Forage, Apiculture, and PRF final index values and payment factors are issued on intervals 629 and 648 (ending month of June), reference PM-17-047, 4/30 and 8/31 filings.

2017 ADM Area Rate & Area Coverage Level updated on cotton STAX (plans 35 and 36) to move Area Loss Trigger = 0.90 from Price Volatility 0.00 to all

available price volatilities to correct for errors on processing, 11/30 filing. 2018 Special Provisions and ADM are now issued for the 8/31, 9/30, and 10/31 filings except for PRF/API, almonds, apples, olives, and Whole Farm Revenue Protection (WFRP). SCO (plan 31) ADM will be issued later (August 22-25) for applicable commodities.
