2014 ARPI final county yields and final county revenues on wheat are issued via ADM Area Risk Rate, reference PM-15-016, 6/30 and 11/30 filings.

2015 Floyd County, Texas Special Provision and ADM Date on STAX cotton are updated to correct the final planting date (FPD) from 6/27/2016 to 6/12/2015.

Besides the incorrect calendar year, the date is to align with the ARPI FPD which is the COMBO FPD plus the 7 day late planting period.

LRP Lamb ADM Subsidy Percent removed for the 20 week endorsement will not be offered for 2015 and beyond.
