2018 SCO final county yields and final county revenues are issued for 29 commodities, reference PM-19-031, 11/30 filing. 2019 Margin Protection (MP) now has yield year of 2018 records populated on ADM Historical Yield Trend to be used to

calculate premium credits, 6/30 and 11/30 filings. 2019 ADM Area Coverage Level and ADM Price updated to populate final index values and payment factors for Annual Forage, Apiculture, and PRF for interval 627 with an ending month of April, reference PM-19-032, 4/30 and 8/31 filings. 2020 ADM Layout is reissued to add record category codes 17 and 18 for ADM Price. 2020 ADM Price is reissued for Annual Forage (0332) Dual Use (DU) option records to populate record category code with code 17 - Sub County and Insurance Option, 4/30 filing. 2020 ADM Document Builder and Special Provisions are reissued for Hybrid Vegetable Seed (0066) to add statement 25556, 4/30 filing.
