2017 ADM Price is now released for all plan 90/31 (silage sorghum will be based on corn so issued late January), 50, 51, and 55 commodities; combo cotton for cottonseed, combo rice for option DC; zero volatilities for: corn silage and blue corn (plans 2/3/5/6/32/33), canola-rapeseed (plans 2/3/32/33), 11/30 filing.

2017 ADM Price updated for PNW dry peas spring type 089, 6/30 filing.
