2019 RY ADM Price has been updated to issue prices for organic certified and organic transitional white and waxy corn for plans 01, 02, 03, 31, 32, and 33, 11/30 filing. 2020 RY ADM Document Builder and Special Provisions are reissued for Texas Citrus Tree commodities Grapefruit Trees (0208), Lime Trees (0210), Orange Trees (0207), and Tangerine Trees (0193) to add statement 25651 which provides clarification on distance and acreage requirements to quality for option units, 6/30

filing. 2020 RY ADM, Special Provisions, and related files are now issued for the August 31, September 30, and October 31 filings except for 8/31 Cherries, Whole Farm Revenue Protection, Apiculture, Pasture, Rangeland, and Forage, and Olives.
