Additional notes and details regarding this data release:

2022 RY ADM Layout updated to add Pace Date ID and Pace Rate ID fields to ADM Insurance Offer, create new ADM Pace Date and ADM Pace Rate records, update ADM Quality range low and high factors to allow 3 decimals, and add record category 09 for ADM Subsidy Percent.

2022 RY ADM and Special Provisions are now issued for Micro Farms, 8/31 filing. 2022 RY ADM Subsidy Percent is reissued for WFRP plan 76 to populate data by commodity code and commodity range.

2022 RY ADM Quality is reissued for wheat quality ID 6 to populate the Special

Grade - Ergoty range low and high factors to 3 decimals.

2022 RY ADM and Special Provisions is now issued for cucumbers and hemp, 11/30 filing.

2022 RY ADM Price is updated to correct prices for Hybrid Sweet Corn Seed in Umatilla, OR, 11/30 filing.
