Additional notes and details regarding this data release:

2019 Special Provisions, ADM, and related files are now released for the 1/31 filing (excluding prices on FL citrus & trees along with Pecan Trees to be issued in January). 2019 Macadamia Trees catastrophic price is now corrected to be 55% of Reference Maximum Dollar Amount rounded up, 8/31 filing. 2018 ADM Price and ADM Area Coverage Level updated for a clear and obvious error by NOAA impacting select grids in New Mexico and Texas on PRF, Apiculture, and Annual Forage for

March through early September. Also updated values for RY 2019 Annual Forage which includes Sep-Oct (Growing Season 1).
