## Crop Insurance Deadline Nears in Maine for Spring Planted Crops, Whole-Farm Revenue Protection, and Micro Farm Program

RALEIGH, N.C., Feb. 15, 2022 — The USDA's Risk Management Agency (RMA) reminds Maine corn, forage seeding, fresh market sweet corn, green pea, hemp, potato, soybean, spring barley, spring oats, and spring wheat growers that the final date to apply for crop insurance coverage for the 2022 crop year is March 15. Growers also have until March 15 to apply for coverage under the <a href="Whole-Farm Revenue Protection">Whole-Farm</a> Revenue Protection policy and the new <a href="Micro Farm Program">Micro Farm Program</a>. Current policyholders who wish to make changes to their existing policies also have until March 15 to do so.

Federal crop insurance is critical to the farm safety net. It helps producers and owners manage revenue risks and strengthens the rural economy. Coverage for corn, forage seeding, fresh market sweet corn, green peas, hemp, potatoes, soybeans, spring barley, spring oats, and spring wheat is available in select counties. Growers are encouraged to visit their crop insurance agent soon to learn specific details for the 2022 crop year. Additional crops may be eligible for coverage under a written agreement. Crop insurance coverage decisions must be made on or before the sales closing date.

RMA is authorizing additional flexibilities due to coronavirus while continuing to support producers, working through Approved Insurance Providers (AIPs) to deliver services, including processing policies, claims and agreements. RMA staff are working with AIPs and other customers by phone, mail and electronically to continue supporting crop insurance coverage for producers. Farmers with crop insurance questions or needs should continue to contact their insurance agents about conducting business remotely (by telephone or email).
