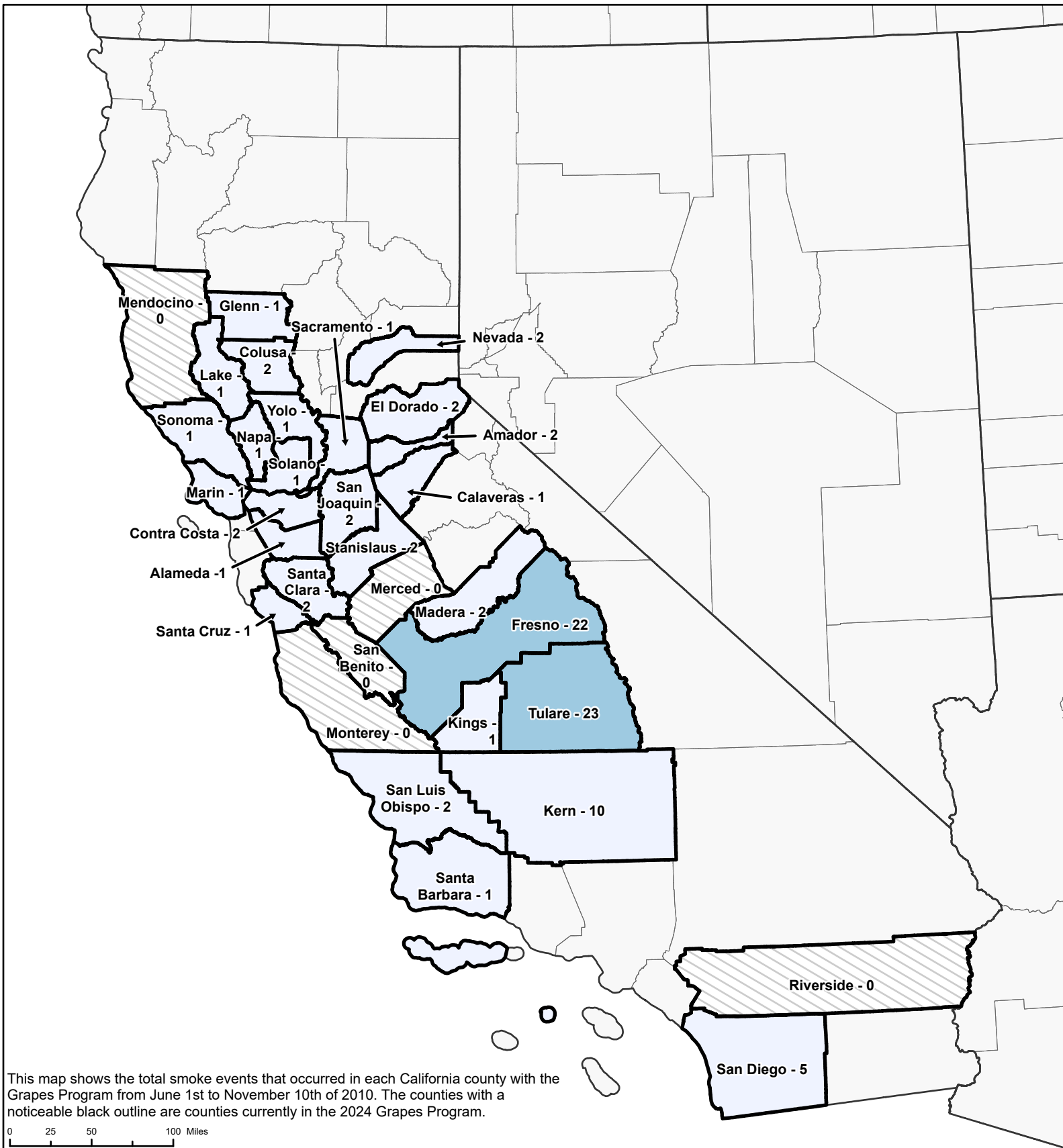




Smoke Events in California Counties with Grapes Program

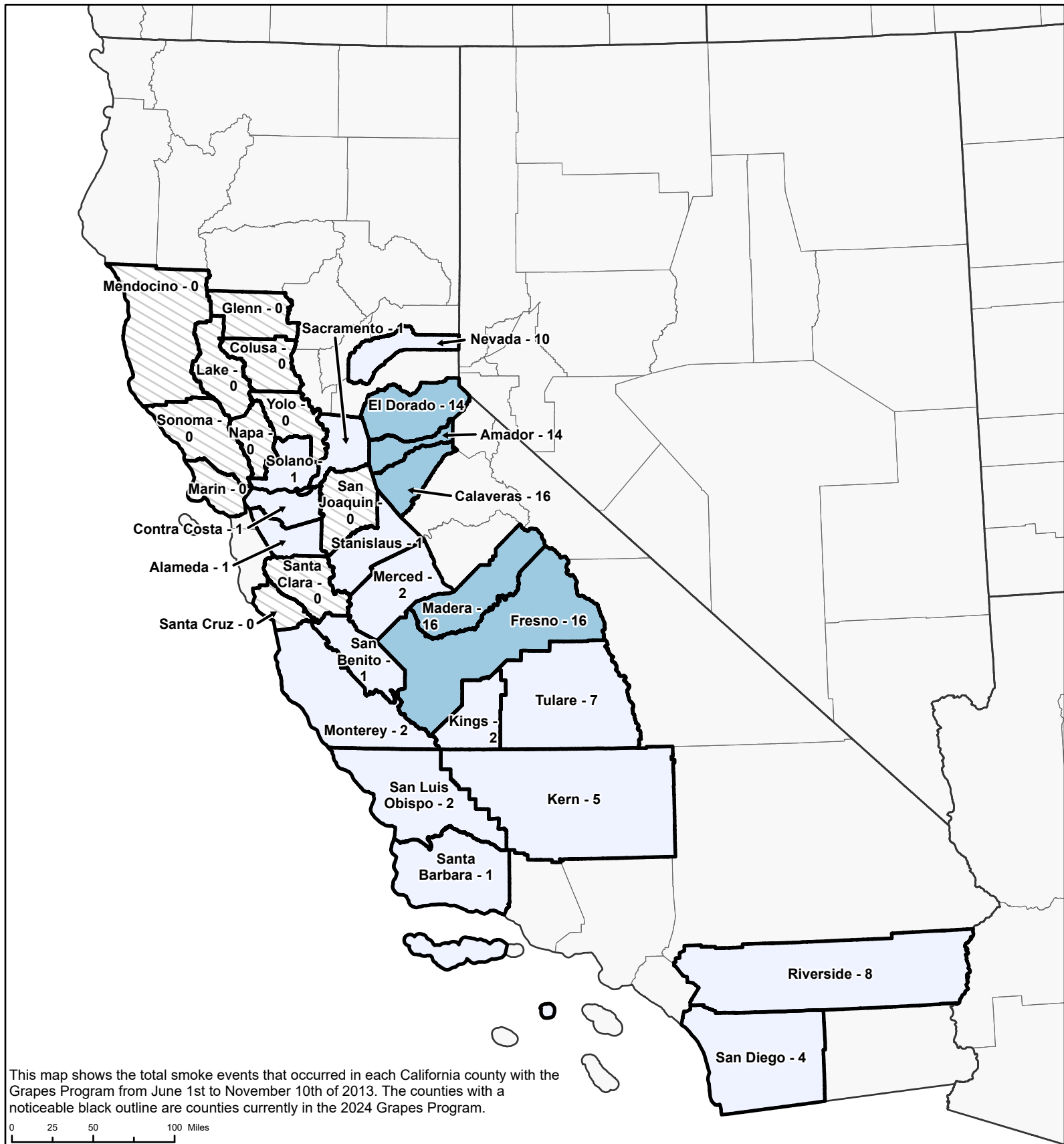

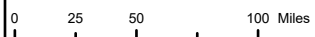

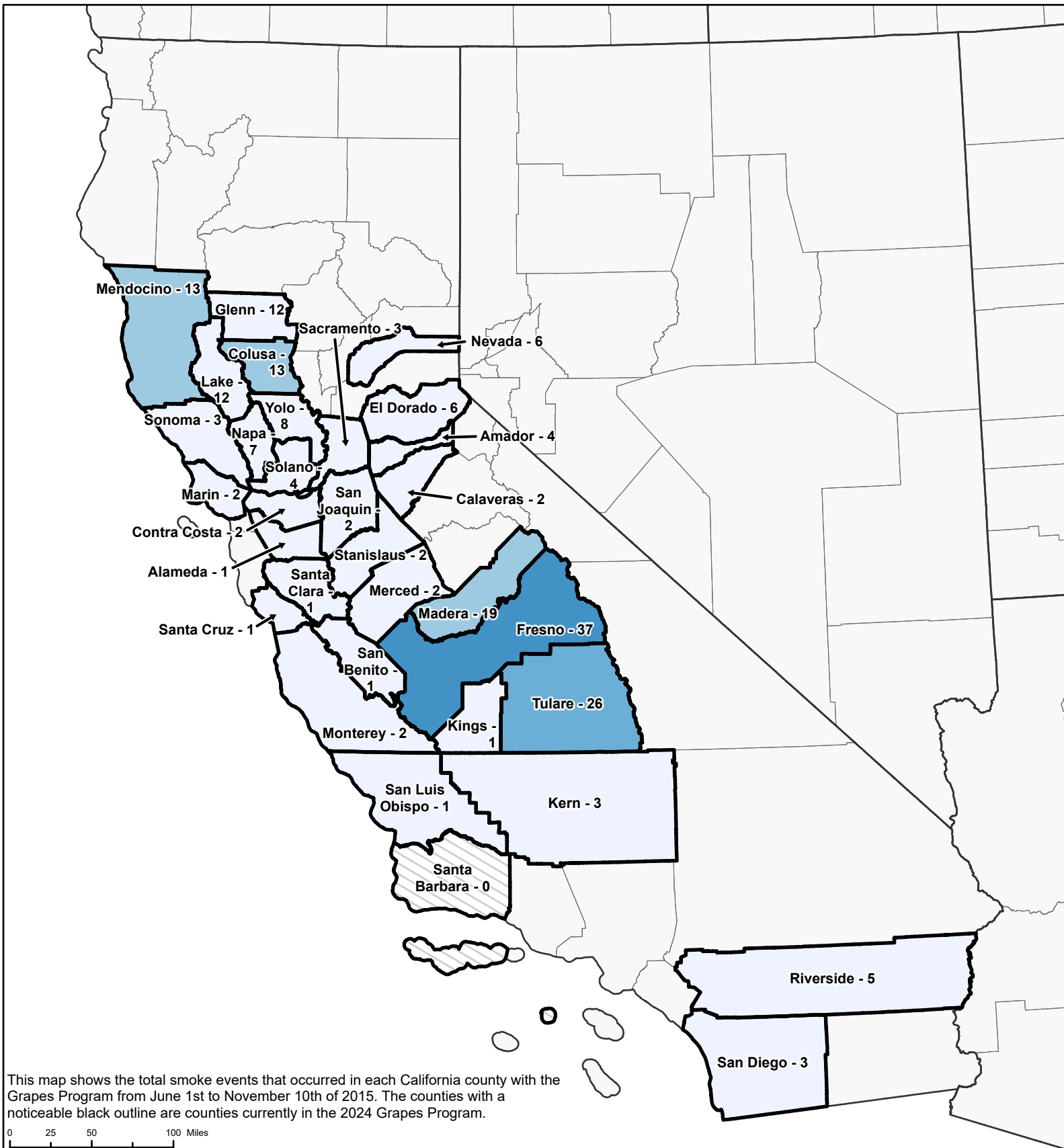





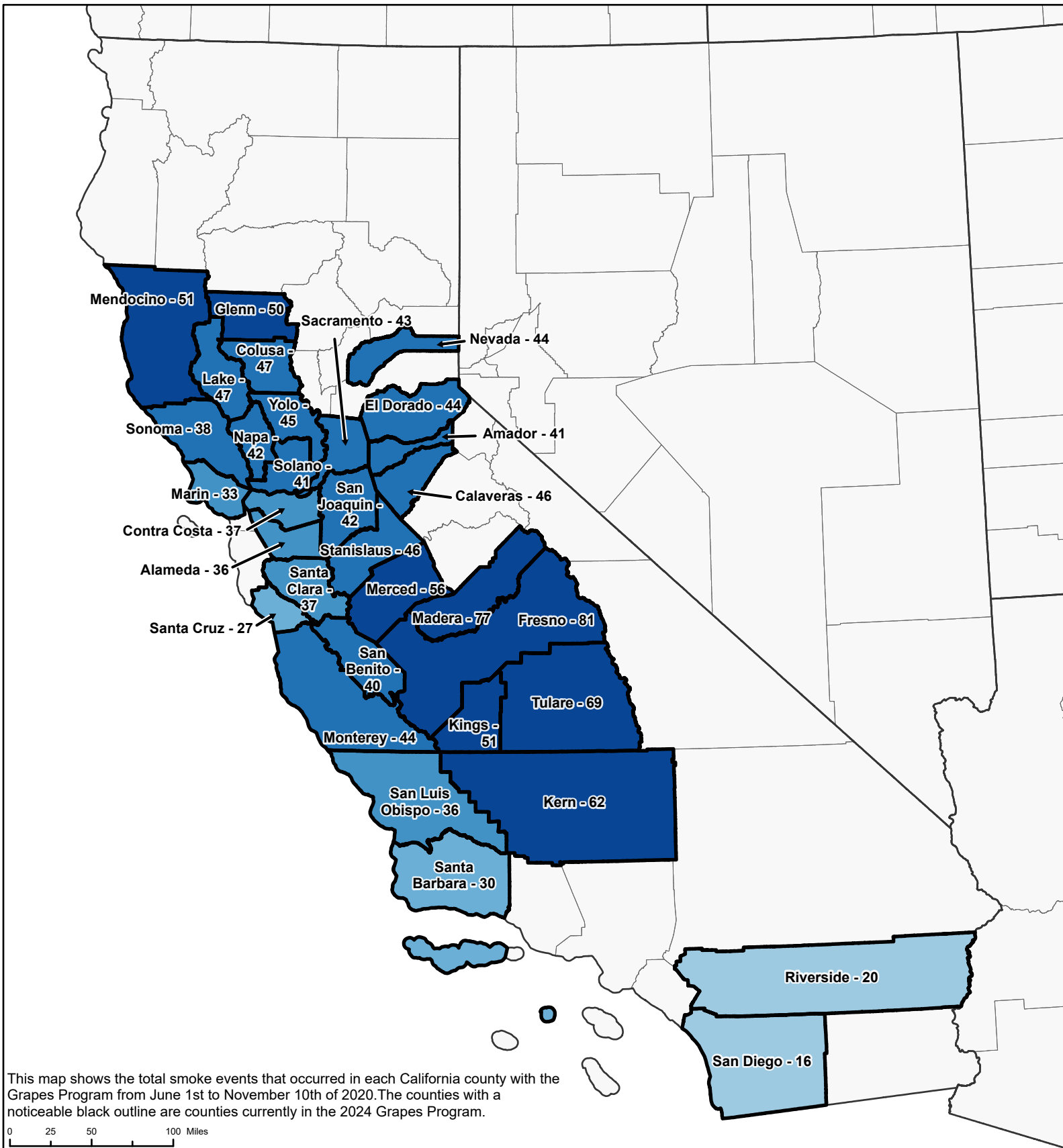





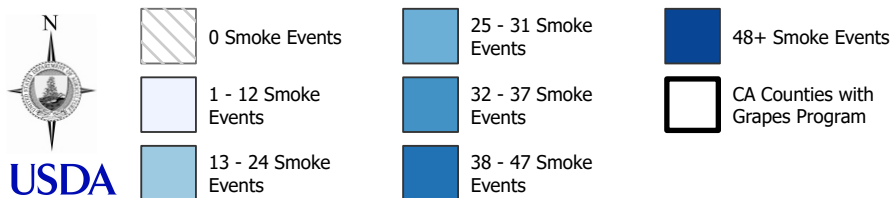
