**Entity types may change within a Category without incurring LSR as long as the Id Number does not change. Such as: I, S, and X; or C and Y; or T and R; or H, V, W, and A.**

**Notes:**

FLB – First and Last Name or Business Name required

BUS – Business Name required

**A RMA issued ID Number will use the same DAS edits/requirements as SSN.**

Spousal – Married

SBI records must be reported with first submission

If an SSN is reported on the primary 10, then there must be 1 SBI record with an ID Type of '1' (SSN).

If an EIN is reported on the primary 10, then there must be 2 SBI records with an ID Type of '1' (SSN)

BIA #

First 5 digits are the FIPS State and County code.
